

In 2021, Pilgrim's Pride Corporation (Pilgrim's Pride) successfully issued a \$1 billion sustainability-linked bond tied to efforts to reduce greenhouse gas emission intensity across its global operations, the first of its kind to be done by a global meat and poultry company.

PILGRIM'S PRIDE CORPORATION SUSTAINABILITY-LINKED BOND DECLARATION

WHEREAS, Pilgrim's Pride issued a sustainability-linked bond in accordance with ICMA's Sustainability-Linked Bond Principles (SLBP) in 2021 to demonstrate its commitment in the fight against climate change and alignment with the Paris Agreement under the United Nations Framework Convention to reduce Greenhouse Gas (GHG) emissions.

WHEREAS, Pilgrim's Pride identified select characteristics of its sustainability-linked bond, including selection of key performance indicators (KPIs), calibration of sustainability performance targets (SPTs), bond characteristics, independent verification, and reporting.

WHEREAS, Pilgrim's Pride hired a third party, SGS, to conduct a limited assurance audit for GHG Scopes 1 and 2 emissions in accordance with the bond offering requirements.

NOW, THEREFORE, LET IT BE KNOWN THAT:

1. Reporting: SGS completed a limited assurance audit for Pilgrim's Pride worldwide operations, excluding Pilgrim's Food Masters due to its recent acquisition, on May 19, 2022, for the years ended 2019, 2020, and 2021. Click each year to view the respective verification provided by SGS.

2. Independent Verification: In SGS's opinion, the GHG emission reporting assertion by Pilgrim's Pride is materially correct and is a fair representation of the GHG emissions and has been prepared in accordance with ISO 14064 – GHG quantification, monitoring, and reporting.

3. KPIs: Referencing reported GHG emission intensity performance from 2019 to 2021, verified by the limited assurance audit by SGS, Pilgrim's Pride is currently on track to meet its Scopes 1 and 2 GHG emission intensity reduction requirements as stated in the Bond Framework.

During Pilgrim's Pride's further preparation of Scopes 1 and 2 GHG emissions data, to prepare for the limited assurance audit conducted by SGS, Pilgrim's Pride identified key areas across each business unit to improve upon for data quality. The data improvement developed a more complete set of data provided to SGS for audit and resulted in a re-baselining of Pilgrim's Pride's Scopes 1 and 2 GHG Emissions listed in the Sustainability-Linked Bond for calendar year 2019 as allowed by the Bond

Due to the improved data which resulted in a re-baseline of the Sustainability-Linked Bond targets, the following Emission Reduction Targets in absolute number, are updated from the originally stated targets; however, these updated targets still represent a 30% reduction in Scopes 1 and 2 GHG emission intensity by 2030.



Since 2019, Pilgrim's Pride has reduced Scopes 1 and 2 GHG emission intensity by 10%, invested \$18.7 million in capital emission-reduction projects in Pilgrim's-owned facilities, and increased our total electricity use from renewable energy sources to 7.4% with expectations for this percentage to continue increasing.

Pilgrim's Pride will continue to publish updates in the third quarter of each year in the annual sustainability report on progress against the sustainability-linked bond performance requirements for Scopes 1 and 2 GHG emission intensity reduction.
